Jerseys: All team members must have same colored jerseys or matching shirts

K through 2nd Grade

Rules: High school rules will apply with the following exceptions:

- a. 20 min. running halves.
- b. No full court press, defense starts at half-court
- c. Man to man defense can be used–NO ZONE DEFENSE–NO DOUBLE TEAMING
- d. 28.5 inch basketball should be used. Teams are to bring their own basketball
- e. Coaches are responsible for their spectators.
- f. Adult supervision is required for all children present at the game (players, fans, family, friends, etc.)
- g. Each team should bring 2 duplicate sets of colored wrist bands
- h. No Score will be kept up to 2nd grade
- i. No Back court violation will be called
- j. No 3 seconds in the key will be called
- k. Free substitutions but should be done on time outs or slow times
- l. 2 time outs per half
- m. Free throws will be used only in 2nd grade games if coaches decide

Additional Guidelines

Traveling will not be called unless player is taking the basketball like a football and not making an attempt to dribble after being warned a couple of times

We do not call double dribble; instead try to teach them as they go

We do not take time for foul shots unless both teams agree. If they agree I wouldn't do that until late in the game.
